

2024 NCHL INTERNATIONAL HEALTHCARE LEADERSHIP AWARD

The National Center for Healthcare Leadership (NCHL) is dedicated to advancing healthcare leadership and organizational excellence by building diverse, inclusive, and collaborative relationships in the US and abroad. NCHL is pleased to accept nominations for the 2024 NCHL International Healthcare Leadership Award, which honors a leader whose commitment, values, and contributions have made a significant and positive impact on the provision of healthcare across international borders. Nominees may represent organizations that participate in one of NCHL's membership programs – such as the US Cooperative for International Patient Programs (USCIPP) – or come from organizations completely outside of any NCHL program. Nominees should be actively engaged in the field and have significant international influence. Self-nominations are not eligible. Generally, nominees should currently be in a senior leadership role or previously have been in a senior leadership role. Nominees do not need to be currently employed.

The recipient of the **2024 NCHL INTERNATIONAL HEALTHCARE LEADERSHIP AWARD** will be honored at the **2024 Gail L. Warden Leadership Award Celebration** on Tuesday, November 19, at the Field Museum in Chicago.

3. Shows strong leadership practices by serving as a role model, mentoring others, and creating high-performing teams.
4. Has achieved measurable improvements in organizational performance and value.
5. Is recognized and respected within the field and uses this influence to positively shape the industry.
